

Plaintiff In Xarelto Lawsuit Claims Anticoagulant Caused Fatal Parenchymal Hemorrhage

BloodThinnerHelp.com reports on a lawsuit which was filed against Xarelto manufacturers Janssen Pharmaceuticals (a subdivision of Johnson & Johnson) and Bayer AG regarding the blood thinner. The suit is just one of more than 2,800 cases which were filed in federal courts across the nation and later consolidated by the U.S. Judicial Panel on Multidistrict Litigation to form MDL No. 2592. The plaintiffs involved in the MDL all commonly allege that Xarelto can cause sudden uncontrollable bleeding episodes which can result in lasting injuries or even death.

The plaintiff involved in this particular suit is a daughter who is filing on behalf of her deceased father. Her case was initially filed under number 2:14-cv-00159-cr in a Vermont federal court. Details within court documents show that the woman's father passed away suddenly after suffering a parenchymal hemorrhage (or brain bleed) which the family believes was caused by the anticoagulant he was taking at the time of his death. Because Xarelto works to thin a patient's blood, doctors trying to save the man were unable to clot his blood, causing the bleed to become fatal.

Xarelto has quickly become the subject of more than 3,000 total lawsuits: over 2,800 consolidated in the Louisiana MDL and another 550 or more cases which have been formed into a mass tort group in Philadelphia by the Court of Common Pleas. The MDL cases have slowly been progressing toward trials, and recently went through bellwether trial selections. They await a monthly status conference to be held at the end of February, 2016. All cases are able to be consolidated due to the fact that they contain strikingly common allegations and have been filed against the same defendants. The consolidation process is expected to help fast track litigation, saving time and finances for everyone involved, and avoiding different rulings by more than one judge and duplicative discovery.
